

**Black River District Recognition Banquet
2018 Awards Nomination Package
General Guidelines for All Leader Awards**

All nominations must be signed to be considered.

With the exception of Distinguished Leader Award, nominee does not have to be from your unit.

If you don't know all of a person's qualifications go ahead and submit the nomination with as much information as you have. Someone else may have submitted the needed information.

Nominee should not nominate him/herself. That defeats the whole purpose and spirit of the award.

Nominee must not have already received the award for that position.

It is encouraged that all nominees must be fully trained in the position in which they're being nominated.

In the event the nominee is not trained, accomplishments will be taken into consideration. This includes completion of initial entry training and the appropriate split for their unit position (or the equivalent training program for when they assumed that position). Webelos Leaders must have also completed Outdoor Webelos Leader Training (OWL).

Scoutmasters and Assistant Scoutmasters must have completed Introduction to Outdoor Leader Skills (IOLS). Commissioners must have attended College of Commissioner Science or Commissioner Basic Training. Assistants may be nominated, as long as they meet the same training and tenure requirements.

There may be only one award presented in each category with the exception of Distinguished Leader Award.

Nominations must be received no later than nomination deadline date (see the attached form) to be considered by the nominating committee. This committee will consist of several Scouters representing each of the programs in the district.

If there are no nominations received for a particular category, that category will be eliminated from the awards banquet. There will be no carry over or changes of category by the nomination committee to fill an award category.

Nominations can be mailed or emailed in to the address on the form, given to your Unit Commissioner or the District Executive.

Your email submission will serve as your signature on the form. If emailing, simply use the form and answer all questions.

All forms are due no later than Nov 15, 2018

EXPLANATION OF AWARDS

As a movement whose leadership is overwhelmingly volunteers the Boy Scouts of America realizes the need to recognize the invaluable services that men and women render to youth. In addition to the thanks, praise and recognition that come to those who serve their communities with utmost efficiency, the Boy Scouts of America has established district awards that are given for distinguished service to youth. The criterion is different for each award, but there is one common thread. The awards are granted by one's own peers in Scouting and do not come as the result of any prescribed course of action or tests to be accomplished.

DISTINGUISHED LEADER AWARD: This award is granted for outstanding service to youth, within the individual unit outside the line of regular duty and upon nomination of the unit. (This award can be presented to single or multiple individuals and would only be presented once per recipient)

DISTRICT AWARD OF MERIT: This award is granted for outstanding service to youth, within the local district outside the line of regular duty and upon nomination of the district. It is the highest award conferred by district. (Normally only two are presented.)

ED WILLIAMS SCOUT SPIRIT AWARD

This award is presented to the Scouter who has shown exceptional Scout Spirit defined as; Scout spirit applies to how a Scouter lives and conducts his 'daily' life. He shows Scout spirit by being a role model to his peers, living by the Scout Oath and Law. The concept of Scout spirit is not based on how many Scouting events or outings a Scouter attends, but rather by how he helps bring out the best in others as a reflection of his own character and attitude in his 'daily' life.

CUB SCOUT LEADER OF THE YEAR

This is given to the leader who has put forth extra effort to provide exceptional activities and leadership to the youth of the unit. They have provided help when needed to the pack and committee leaders without hope of personal recognition or gain.

BOY SCOUT LEADER OF THE YEAR

This is given to the leader who has put forth extra efforts to provide exceptional activities and leadership to the youth of the unit. They have provided help when needed to the troop and committee leaders without hope of personal recognition or gain.

COMMITTEE MEMBER OF THE YEAR

This is given to the leader who has put forth extra efforts to provide exceptional activities and leadership to the youth of the unit. They have provided help when needed to the unit and unit leaders without hope of personal recognition or gain.

ROOKIE OF THE YEAR

This is given to a first year scouter who has come in this past year and has made a huge impact on either a pack, troop, venturing or on the district level.

WE MEDLIN DEDICATION AWARD

This award is presented to the Scouter or Non-Scouter who has shown exceptional dedication to Scouting by demonstrating a long term commitment to Scouting on a community level. This candidate has an extreme passion for scouting and the scouting program. This candidate incorporates many of their daily activities to promote and involve Scouting matters and issues.

REQUIREMENTS:

1. A nominee must be registered with the district or one of its units and be in a position where he/she has rendered service of an outstanding nature at the unit and/or district level, based upon the award being recommended.
2. A nominee must have rendered noteworthy service to youth. The nature and value of the "noteworthy service" may consist of a single plan or decision that contributed vitally to the lives of a large number of youth or it may have been given to a small group over an extended period of time.
3. Consideration should be given to the nominee's position and the corresponding opportunity to render outstanding service beyond the expectation of duty.
4. The nominee's attitude toward and cooperation with the district and council is to be taken into consideration.

PROCEDURES:

1. Annually, the District Chairman will appoint a District Awards Committee of not more than five or less than three members who will consider all candidates and make recommendations. The Committee's term of office shall be for one year from the date of appointment.
2. These recommendations should be submitted confidentially to the District Scout Executive who will inform the District Awards Chairman. To avoid possible disappointment, please do not advise the nominee in any way of your action on his or her behalf.
3. The Awards Committee will consider recommendations from all units in confidentiality. The Awards Committee is also empowered to recommend individuals for awards.
4. The District Scout Executive serves as the recorder of all decisions taken by the Awards Committee.
5. The Awards Committee then prepares the awards and certificates for presentation to those selected for receiving awards. National and Council awards are forwarded by the Committee (recorder/DE) to Council for further processing of awards and certificates.
